

PAYMENT INSTRUCTIONS 2020-2021

All payments must be made using the **FACTS** Payment System including payment made-in-full. (PLEASE NOTE that entry into the **FACTS** Payment System will occur as **one of the steps in the online enrollment process.**)

Within the **FACTS Payment System**, each family (or **each parent or guardian making separate payment**) will:

- Establish a FACTS Payment account
- Select a payment plan for 2020-2021
- Make an initial (non-refundable) payment for \$2,500 for each student

Full tuition is due on or before **June 5, 2020** to avoid additional charges. All other payment plans carry additional processing/convenience fees as outlined below.

Following are Payment Plan Options for 2020-2021:

1. Payment-in-Full – **due on or before June 5, 2020** with no additional processing fee. Credit card, check (payable to FACTS) or electronic check may be used. A fee of 2.85% will be charged for all credit card payments. Purchase of the Tuition Refund Plan of \$300 is highly recommended.
2. Two Payments – **one payment in June 2020 and one payment in January 2021** with a \$210 convenience fee added to each of these payments... Credit card, check (payable to FACTS) or electronic check may be used. An additional fee of 2.85% will be charged for all credit card payments. Purchase of the Tuition Refund Plan of \$300 is highly recommended.
3. Monthly Payments – **payment will begin in June 2020 and end in March 2021**, with an \$85 convenience fee added to each of these payments. Credit card, check (payable to FACTS) or electronic check may be used. An additional fee of 2.85% will be charged for all credit card payments. Purchase of the Tuition Refund Plan of \$300 is highly recommended.

PLEASE NOTE that **accounts must be current on 8/15/2020 in order for student(s) to begin school. Any tuition refunds after 8/15/2020 will be subject to the terms of the Refund Tuition Plan.** In addition, **accounts must be current on 12/15/2020 in order for student(s) to return to school in January.**

TUITION REFUND PLAN \$300

If purchased, the Tuition Refund Plan will refund 60% of the unused portion of the paid tuition should you decide to withdraw your student from school for any reason, and 75% will be refunded if the withdrawal is for medical reasons. The Tuition Refund Plan is optional unless it was made a condition on your student's contract.
